1. Pursuant to OUA Memo 00-1020-0116 signed by Usec. Alain Del B. Pascua of the Office of the Undersecretary for Administration re: Promotion of DepEd TV, DepEd Commons, and DepEd YouTube Channel and other Digital Platforms, this Office directs all schools to actively promote all official platforms of the Department of Education related to blended learning.
