This is in connection with DepEd's commitment to provide quality, accessible, relevant, and liberating basic education for all and to respond the challenge of Bawat Bata Bumabasa.

The Schools Division Offices (SDOs) are advised to enjoin all schools and learning centers to hold activities for this month-long celebration with strict observance to the health protocols and guidelines set forth by the IATF and the local government.

The NRM shall culminate with the nationwide synchronized story reading time on November 27, 2020, 9:00 a.m. Philippine Standard Time (PST). November 27 of every year was declared by Republic Act No. 10556 as Araw ng Pagbasa, which is a regular working holiday to be celebrated in all elementary and secondary schools in the country.


Expenses incurred in the conduct of this activity shall be charged against local funds, subject to the usual government accounting and auditing rules and regulations.
