

#### EBOOK Report

The Ebook Report to be submitted must show best practices amidst challenges faced during the COVID-19 pandemic. The report must be substantiated with supporting evidence such as certifications, pictures, programs, narrative reports of accomplishments and video documentation.

### VIDEO DOCUMENTATION REQUIREMENTS

The following are the requirements on the creation and submission of the video documentation:

- Must show video of best practices amidst challenges faced during COVID-19 pandemic;
- 2. Must be a high-quality Audio-Visual Presentation in MP4 format;
- 3. Must be uploaded to the official JCI website. In case of inability to upload due to limited accesss/connectivity, it must be saved in a flash drive (use of CDs/DVDs is discouraged); and
- 4. Must not run for more than five (5) minutes.
- 5. Must contain shots within the prescribed timeframe: January 1, 2020 to October 31, 2020.
- 6. Must be submitted and labeled with the following information:

#### KICK-OFF PROGRAM

The National Virtual Kick-off Launch of Project W.A.T.C.H. was held last July 29, 2020. The reschedule took into consideration the applicable guidelines set by the Inter Agency Task Force on Emerging Infectious Diseases (IATF-EID), the Department of Health (DOH), DepEd and local government quarantine rules, in light of the COVID-19 public health situation. The conduct of said event was consistent with the IATF-EID/DOH/LGU guidelines on mass gatherings. Schools <u>may</u> also opt to conduct their virtual Kick-Off taking into careful consideration existing IATF-EID/DOH/LGU guidelines on mass gatherings.

- 1. A special award shall be given to the school that best exhibits, on the day of the virtual kick-off, the practices that aim to strengthen punctuality and honesty even working at home or that the school plans to implement for the whole school year.
- 2. The said virtual kick-off shall involve learners, teachers, non-teaching personnel, stakeholders, and other members of the community.

- 3. Running time for the video report shall be five (5) minutes only. Exceeding time shall have corresponding deductions.
- 4. Entires must be uploaded to the website together with the Ebook Report and the Project W.A.T.C.H. Audio Video Presentation. In case of inability to upload online, save in the same USB flash drive as the video documentation report.
- 5. Filename must be: VIRTUAL KICK OFF PROGRAM (Name of School).

#### GENERAL GUIDELINES

- Upload all video documentation reports such as Project W.A.T.C.H. and Virtual Kick Off Program on the website. Organize and label documents before uploading on the website. In case of inability to upload online due to limited access/internet connectivity, save the reports in one flash drive only:

Mode of validation will be announced later by the Validation Team subject to prevailing IATF, DOH, DepEd and LGU rules/guidelines.
