

**REQUEST FOR PRIVATE SCHOOLS TO REVIEW THEIR SY 2020-2021
MISCELLANEOUS FEES IN THE LIGHT OF COVID 19 PANDEMIC**

To. The Schools Division Superintendents
Presidents/Directors/Principals of Private Schools
All Others Concerned

1. This Regional Office has received numerous appeals from parents requesting that some **miscellaneous fees (other fees)** that they have consented to be collected for SY 2020-2021 will no longer be collected by private educational institutions, inasmuch as payment of such are deemed no longer necessary due to stringent regulations imposing physical distancing. Parents argue that the fees that they have consented to pay for this school year will not be commensurate to the kind of services that their children will be getting and that they will be paying for something which their children will never avail of such as:

- 1) Laboratory;
- 2) library,
- 3) athletic;
- 4) medical-dental;
- 5) practical arts;
- 6) audio visual,
- 7) campus ministry and many others.

2 The above concern has been forwarded to the Office of the Honorable Secretary for appropriate action and said request is currently awaiting response.

3. As an offshoot of the above, the Private Education Assistance Committee (PEAC) was formally requested also to extend the deadline imposed on their members relative to the submission of approved tuition and or miscellaneous fee applications. Same is also awaiting response.

4. With the above-cited development, this Regional Office respectfully informs that all requests pertaining to miscellaneous fees for SY 2020-2021 are held in abeyance pending DepEd Central Office and PEAC actions as stipulated in paragraphs 3 and 4.

5. Private schools in Region XI are requested to review their SY 2020-2021 miscellaneous fees and determine whether or not they are appropriate under the period of national health emergency.

The process and the mode for reappraising will depend upon the private school but it is strongly suggested that their parent-stakeholders must be consulted on the matter in consonance with Section 182 (a) of DO 88, s. 2010 or the 2011 Manual of Regulations for Private Schools in Basic Education which states “The increase in tuition or other school fees as well as new fees or charges shall be subject to the following conditions: a. Consultation.” The process and mode of consultation must strictly abide with all the health and safety protocols imposed by the DOH, the IATF and the Office of the President.
