- Currently, Digos City has increasing number of COVID-19 cases.
- There are other COVID-19 variants that are super spreader compared to the original variant.
- We cannot guarantee that the personnel in Megans Function Hall and the participants are not carriers of COVID-19 or included in the contact tracing.
- The City Health Office limits the conduct of swab testing per day, so not all suspect cases are tested.
- As to date, we have 4 SDO personnel who are confirmed positive of COVID-19 and 1 teacher from Balabag National High School.

RECOMMENDATIONS:

- Conduct the activity via online platform.
- That with the COVID-19 could be about 10 times more deadly than the seasonal flu and this is what makes it more dangerous, the Safety Management Team/Committee strongly recommends that the conduct of the 1st Quarter DMEA shall be online...the sure fight protocol to stay safe.
