- 1. - 6. A subsequent Brigada Eskwela Central Office Memorandum shall be issued later which shall set the guidelines and criteria for the selection of the Best Implementing Schools.
- 7. The Public Schools District Supervisors shall select their District Entries to the Division Level which shall be evaluated by the committee composed above. Official School Entries shall prepare and submit their Brigada Eskwela Portfolio and 5-minute video for perusal by the evaluators during the school validation visit.
