

- a) Though Guideline No. 5 on the 10-year DepEd experience is still in effect, teachers, school heads, education program supervisors and public schools district supervisors who have rendered four (4) to nine (9) years of exemplary service shall be considered in the Search.
- b) Division personnel with exemplary performance in position items created less than 10 years are included in the Search.
- c) Division Officers are strongly encouraged to widely disseminate the activity so that maximum participation shall be achieved.

Relative to the Regional Memorandum no. 39 s.2021 released to your end, this regional office hereby adds this information:

- 1. All division offices are strongly encouraged to widely disseminate the activity so that all teaching and non-teaching work force would be aware of this annual search for employees' maximum participation, hence, the conduct of the division search is imperative.
- 2. That Guideline no. 5 is still in effect giving priority to the 10 years and above personnel with exemplary service. However, teachers, school heads, education program supervisors and public schools district supervisors who have rendered four (4) to nine (9) years with exemplary service under the Department of Education shall still be considered in the search but are definitely disqualified to the higher award giving-bodies which require ten (10) years in service.
- 3. Those personnel with exemplary performance who were hired with position item created less than 10 years are included in the search.
