The celebration is led by National Nutrition Council (NNC), the country's highest policy-making body coordinating agency in nutrition.
2. DepEd Regional Office XI encourages everyone to participate in the 47th Nutrition Month Campaign with the theme, "Malnutrisyon Patuloy na Labanan, First 1,000 Days Tutukan". This necessitates continuing efforts to combat malnutrition in the nation, which is likely to deteriorate because of pandemic limited resources of nutrition. It highlights the significance of adequate nutrition throughout the first 1,000 days of a child's life as a preventive activity for stunting and obesity.
3. The objectives of the campaign are to:
 - increase the understanding on the importance of First 1,000 Days of Life and the Philippine Plan of Action as the framework of action to address malnutrition;
 - foster collaboration among stakeholders to scale up nutrition interventions; and
 - generate interaction from stakeholders that we target or the corresponding commitment and actions.
4. Further, all schools are advised to participate the celebration through virtual lectures/ activities using the 2021 Nutrition Month Talking Points, conduct advocacies on Health and Nutrition and sustain services in cases of emergencies and health crisis.
5. The school SBFP Coordinator and School Clinic-In-Charge shall document the activities and submit accomplishment reports on the conduct of 2021 Nutrition Month Celebration to the SDO Health and Nutrition Unit through the Records Section on or before Aug. 2, 2021.

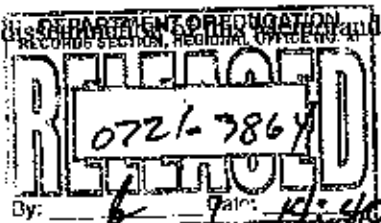
The objectives of the campaign are to:

1. The Department of Education (DepEd) enjoins all learners, teaching and nonteaching personnel, officials, and other stakeholders, including parents to participate in the **2021 Nutrition Month Celebration** this July. This celebration is led by the National Nutrition Council (NNC), the country's highest policy making body and coordinating agency on nutrition.
2. The theme of the campaign for this year, *Malnutrisyon patuloy na labanan*, First 1000 days *tutukan!*, calls for continued efforts to address malnutrition in the country which is expected to worsen as a result of the pandemic and limited resources for nutrition. It emphasizes the importance of good nutrition during the first 1000 days of the child's life as the strategic intervention to prevent stunting and obesity.
3. The celebration aims to
 - a. raise awareness on the importance of the first 1000 days as a **golden window of opportunity** for a comprehensive package of nutrition and related interventions, to achieve significant reduction in under and overnutrition while contributing to optimal child development; and
 - b. advocate for interventions and services in the first 1000 days as mandated by Republic Act No. 11148 or the *Kalusugan at Nutrisyon ng Mag-Nanay* Act of 2018.
4. All DepEd offices and schools are enjoined to participate in meaningful undertakings, which will highlight the importance of good nutrition in addressing stunting and obesity through focusing on the First 1000 days among children while improving resistance against diseases in times of pandemic. DepEd offices may also conceptualize creative activities for learners and their families utilizing online and other platforms. It is reiterated that such activities after July 10, 2021 are no longer part of the school calendar per DepEd Order No. 012, s. 2021 titled, **Amendment to DepEd Order No. 030, s. 2020 (Amendment to DepEd Order No. 007, s. 2020, School Calendar and Activities for SY 2020-2021)**.
