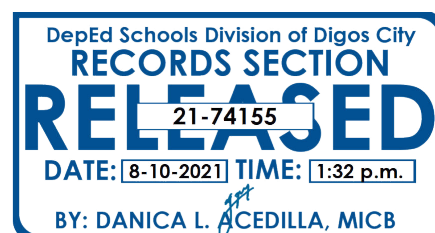
**ATTENDANCE TO THE VIRTUAL REGIONAL TRAINING ON

 ON LEARNER INFORMATION SYSTEM (LIS)

Date : July 28, 2021

Amid the public health emergency due to COVID-19, the Department of Education (DepEd) remains committed to find ways to provide learning opportunities to all Filipino learners for School Year (SY) 2021-2022. In its Basic Education Learning Continuity Plan (BE-LCP) titled Learning Opportunities Shall Be Available: The Basic Education Learning Continuity Plan in the Time of COVID-19.

In 2011, the Department of Education initiated the Learners' Information System (LIS), an online facility that provides for the registration of learners enrolled in public schools. Since its installation, the LIS has allowed the Department to generate the total public and private school enrolment based on the actual registration of learners. It aimed of promoting transparency, informed decision making, and empowerment at different levels of the organization.

The webinar series aims to: a) discuss updates of Basic Education Enrolment Guidelines amid COVID 19 Pandemic; b) ensure common understanding on the what, why and how of the Learners Information System; c) capacitate our teachers, principals, planning officers and other DepEd personnel; d) coordinate plans and activities relevant to effective policy implementation.

To strategize and address the requirements of this undertaking, DepEd Regional Office XI through the Policy Planning and Research Division, will conduct a **Two-Day Regional Training on Learners Information System (LIS) on August 17-18, 2021, at 8:30 A.M. via Facebook Live**. The participants to this activity are to School Registrars and LIS Coordinators of Public and Private Schools from the 11 Schools Division Offices.

Meals, transportation and other incidental expenses of the participants shall be charged against local funds subject to the existing accounting and auditing rules and regulations.

Immediate dissemination of this Memorandum is highly desired.
