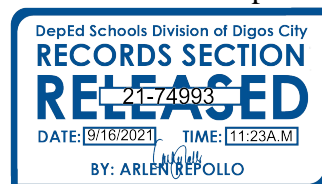

Relative to the herein attached Regional Memorandum No. 052, s. 2021, dated August 26, 2021, this Office relays to the field the new schedule of the Regional Office for the release of private school's permits, certificate of recognition or certificate of compliance, which is in compliance with DepEd Task Force COVID 19 Memorandum 464 (*Reiteration of Corresponding Work-Related Guidelines per Community Quarantine Classification and Ensuring Observance of Strict Health Measures in Work Settings in View of the Threat of the Delta Variant Transmissions*) which desires to guide DepEd Personnel on the guidelines and protocols that must be strictly observed in DepEd workplaces based on the community quarantine imposed over their respective localities and in view of the threat of the transmission of the highly infectious delta variant of COVID-19 in the country.
