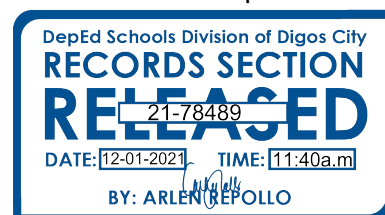

Subject: ADDENDUM ON THE SUBMISSION OF THE VACCINATION DATA OF LEARNERS

Date : November 23, 2021

This refers to the Regional Memorandum dated November 8, 2021, entitled "Submission of the Vaccination Data of Learners", which requires all Schools Division Offices (SDOs) to track and record all learners who received vaccination from all sources, may it be from DepEd schools designated Vaccination Centers, identified Public Vaccination Centers (such as identified by barangays, malls, etc.), and private clinics/hospitals.

In view thereof, all SDOs shall include all eligible learners for COVID-19 vaccination in the weekly consolidation of reports. All 12-17 years old learners, including those 18 years old and above, regardless of grade level shall be included in the Master List of Learners recommended for COVID-19 vaccination in your respective and/or identified fixed vaccination sites.

In addition, all SDOs are required to update the Regional Google Sheets on the Vaccination Data weekly via bit.ly/COVID-19VaccinationData, providing accurate number of vaccinated personnel and learners with first dose and second dose, and data on Adverse Events Following Immunization (AEFI).

Immediate and wide dissemination of this Memorandum is desired.
