1. In reference to the unnumbered Regional Memorandum entitled “Adherence on the Proper Use of Science and Mathematics Laboratory Room and the Delivered Cabinets” dated January 6, 2022 from the Office of the Regional Director, this Office advises all schools to strictly adhere to the intended purpose of the said Science and Mathematics equipment and Science laboratory room, which should be used for Science experiments and other hands-on activities that are very important to the learners’ teaching and learning process.
2. The Department of Education (DepEd), in collaboration with the Bureau of Curriculum Development (BCD) and the Bureau of Learning Delivery (BLD), had delivered Science and Mathematics equipment to all grade levels for public schools through the Bureau of Learning Resource (BLR).
3. Along this line, this Office reiterates the submission of Bi-Annual Monitoring and Evaluation Report of Non-Test Learning Resources for the Science and Mathematics. Please see the attached template in the Enclosures. The deadline of submission of this report shall be on January 21, 2022 thru google drive link: <https://tinyurl.com/Bi-AnnualReportingSciMath> following the file naming template Bi-AnnualReportSciMath\_[Name of School].

Date : January 6, 2021

The Department of Education (DepEd), in collaboration with the Bureau of Curriculum Development (BCD) and the Bureau of Learning Delivery (BLD), had delivered science and mathematics equipment to all grade levels for public schools through the Bureau of Learning Resources (BLR).

During the monitoring, however, the Regional Office discovered that certain schools were not making proper use of the delivered cabinets intended for storing Science and Mathematics equipment, and that Science laboratory spaces were being used for other reasons.

Along these lines, this Office advises all schools to strictly adhere to the intended purpose of the said Science and Mathematics equipment and Science laboratory room, which should be used for Science experiments and other hands-on activities that are very important to the learners' teaching and learning process.
