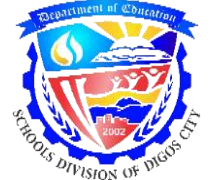



"Undergraduate Scholarships for Students"  
Academic Year 2022**

The Bachelor of Arts Program in Economics (EBA) has established an "Undergraduate Scholarship Program for Students" to provide financial assistance to students who wish to pursue their studies at our EBA Program.

**1. Term of the Scholarship:**

Not exceeding 4 years (8 regular semesters and 3 summer sessions)

**2. Provisions of the Scholarships:**

There are two types of scholarships:

- 1. The full scholarship** will cover the program fee in the amount of 84,000 THB per regular semester and 42,000 THB for summer session. The tuition fee charged by Chulalongkorn University (21,000 THB per regular semester and 5,250 THB for summer session) is not covered by the scholarship.
- 2. The partial scholarship** will cover the program fee in the amount of 42,000 THB per regular semester and 21,000 THB for summer session. The tuition fee charged by Chulalongkorn University (21,000 THB per regular semester and 5,250 THB for summer session) is not covered by the scholarship.

Students are required to pay for other expenses such as travel expenses, accommodation fee, personal expenses.

**3. Condition of Scholarship:**

- 3.1** The term of the scholarship cannot be extended.
- 3.2** Students have to maintain a minimum overall GPAX of 3.50, exhibit proper academic discipline at all times, and remain within the confines of what is acceptable as a CU student in order to continue receiving the grant amount specified above.
- 3.3** Students have to return the entire grant amount received if he/she withdraw from the program or if he/she is dismissed from the program.

**4. Number of Scholarship**

The EBA Program will award:

- Up to seven full scholarships (equivalent to 14 partial scholarships) for Thai students.
- Up to two full scholarships (equivalent to 4 partial scholarships) for non-Thai students.
- One full scholarship for the highest ranking applicant admitted to the EBA program from the Early Admission round.

**5. Eligibility of Applicants:**

Applicants must meet all requirements as follows:

- 5.1** Must have completed high school or the equivalent with a minimum GPAX of 3.50.
- 5.2** Must have passed one of the following English proficiency tests with a minimum score of:
  - IELTS  $\geq$  7.0 or
  - TOEFL (internet based)  $\geq$  90 or
  - SAT (Evidence-Based Reading and Writing)  $\geq$  550 or
  - ACT (English and Reading)  $\geq$  43 or
  - Duolingo English Test  $\geq$  110 or
  - CU-TEP  $\geq$  90 or
  - CU-AAT (Verbal)  $\geq$  500
