- This is to inform the concerned personnel that the enrollment of University of the Philippines' College of Education (UP CEd) Scholars is deferred to the First Semester of Academic Year 2022-2023. This is in connection to OSEC Memorandum List of NEAP and UP-CEd Scholars Batch 2 (second semester) of AY 2021-2022 which was released on December 21, 2021.
- This decision was based on the challenges encountered by the scholars on the completion and submission of their documentary requirements to UP CEd as a result of the recent outbreak of the COVID-19 omicron variant as well as the effects of the damages brought about by typhoon Odette.
- In addition, UP CEd recommended to give adequate time to the accepted teachers to complete documentary requirements for submission and give the teachers time to ponder whether they will continue with the scholarship program given the details presented in the scholars' orientation conducted last January 24, 2022.
- Immediate dissemination of and appropriate action on this memorandum is earnestly desired.
