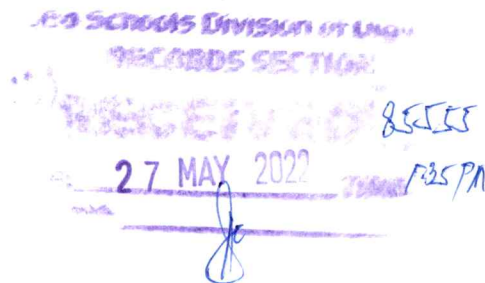

RE: REQUEST OF SISTERS OF MARY SCHOOL – GIRLSTOWN, INC. TO USE COLORADO ELEM. SCHOOL FOR THE CONDUCT OF QUALIFYING EXAM AND INTERVIEW TO THE INTERESTED APPLICANTS FROM THE GRADE 6 STUDENTS

DATE: JUNE 2, 2022 (THURSDAY)

FACTS:

- In reference to the Inter-Agency Task Force (IATF) for the Management of Emerging Infectious Diseases on the Guidelines of the Nationwide Implementation of Alert Level System for COVID-19 Response, **for areas under Alert Level 3, activities shall be conducted at a maximum of 30% indoor venue capacity for fully vaccinated individuals only and 50% outdoor venue capacity** provided that the organizers of the activity are fully vaccinated against COVID-19 while **for areas under Alert Level 2, activities shall be conducted at a maximum of 50% indoor venue capacity for fully vaccinated individuals and those below 18 years old of age, even if unvaccinated, and 70% outdoor capacity** provided that the organizers of the activity are fully vaccinated against COVID-19.
- Pursuant to DepEd Order No 7, s. 1985 re: “Use of Public School Buildings and Grounds for Private and Religious Activities”, paragraph 3, in giving any religious groups permission to use public school buildings and/or grounds/campus on Sundays and holidays for the purpose of holding religious services/activities for the benefit of pupils/students, please be guided by the regulations contained in paragraph 6 of Circular No. 8, s. 1950. These regulations provide that in all cases school property must be safeguarded. Accordingly, for any damage done to it during any religious services/activities held in school premises, the corresponding repair thereon or compensation therefore shall be the responsibility of the organization, group or individual that requested the use of the building and its premises.
- In reference to DepEd Educational Facilities Manual Revised Edition of the 2007 Handbook on Educational Facilities-Integrating Disaster Risk Reduction in School Construction, Chapter V, Educational Facilities Management, letter C, paragraph number 4, holding of religious activities for the benefit of pupils/students and barangay council and other sectoral groups and conduct of religious instructions maybe allowed provided such does not interfere with regular school activities.



COMMENTS:

- The scheduled date of the said activity is June 2, 2022 (Thursday), it will hamper the classes.
- It will interfere the regular school activities.

RECOMMENDATIONS:

- The request to use the Colorado Elementary School shall **NOT** be accommodated.
- The organizer may send request to Barangay Colorado Officials to use the Barangay Gym.



TO: ELEMENTARY SCHOOL HEADS
PUBLIC SCHOOLS DISTRICT SUPERVISORS

1. Herewith is the communication from Sr. Belinda R. Sacayan SM through Mrs. Lorelie J. Marabueno, Teacher I of Colorado Elementary School informing the field that the Sisters of Mary Schools – Boystown & Girstown in Cebu is conducting a qualifying examination and interview for all qualified and interested Grade 6 pupils who would like to finish their secondary education, whose parents are not capable of sending them to school due to poverty.
2. The schedule of screening and examination is on **November 22, 2019** at **8:00 o'clock** in the morning at **Colorado Elementary School, Digos City**.
3. All aspiring scholars should be screened initially by the school heads through the following guidelines:
 1. Must be in 12 years of age or in between 12 -15 years old and have not studied high school,
 2. Must have completed elementary studies or presently enroll in Grade VI,
 3. Must come from poor families with monthly income of Php 5,000.00 or below,
 4. Must not have brothers and sisters studying in any of the four Sisters of Mary Campuses (Sta. Mesa Manila, Silang and Adlas Cavite, Minglanilla Cebu and Talisay City Cebu),
 5. For elementary graduates, must have an average of 80% and above on their Grade VI Report Card and must present original grade VI report card during the qualifying exam,
 6. For those presently enrolled in grade VI, must secure Certification from the School Principal indicating that they are currently enrolled and have general average of 80% and above their latest grading period,
 7. Must be accompanied by one of their parents or guardian on the day of the examination,
 8. Must have a photo copy of their PSA Birth Certificate and present original with 1X1 ID picture (2 copies) and Baptismal Certificate (photocopy).
