## IMPLEMENTATION OF THE ENHANCED ELECTRONIC BILLING AND COLLECTION SYSTEM (EBCS) OF THE GSIS

- To: Public Schools Division Supervisors Public Elementary and Secondary School Heads Teaching and Non-Teaching Personnel concerned All concerned
- 1. In view of the implementation of ninety percent (90%) threshold remittance for the monthly loan amortization of the Enhanced Electronic Billing and Collection System (EBCS) of the Government Service Insurance System (GSIS) effective May 2022, there were personnel that fall below the threshold. With this, there is a need to collect from them the balance of the loans until June 7, 2022 since the system cannot be locked and we need to remit the deductions of the teaching and non-teaching personnel not later than June 10, 2022.
- 2. All payments should be made through Rosario B. Diamante, Administrative Officer IV Cash, our Division Cashier.
- 3. Consequently, failure on the part of the personnel to pay the balance of his loan payables until June 7, 2022, the said personnel will be deleted from the electronic remittance file and deductions will not be remitted including the mandatory deductions for the month of May 2022.
- 4. Remittance of his mandatory deduction including loan repayments for the month of May 2022 will be done upon receipt of his over-the-counter payment.
- 5. Further, the personnel concerned are advised to furnish the Accounting Section the soft copy of the official receipt through its official email address <u>accounting.digos@deped.gov.ph</u> to facilitate the remittance.
- 6. Attached is the list of personnel with loans payable for your ready reference.
