This Office interposes no objection to the request mentioned above provided that the following conditions recommended by the Division Safety Management Committee shall be strictly followed/adhered to:

- Proper coordination with the Public Schools District Supervisors and School Head must be made;
- The vaccination status of the participants shall be checked;
- An inventory shall be made before and after;
- There must be a logbook available for contact tracing;
- During the activity, social/physical distancing shall be observed as well as the wearing of face masks, checking of body temperature, sanitizing or washing their hands and foct bathing at the entrance of the venue;
- Comfort rooms and hand washing facilities must be functional and allowed for use during the event; facilities who has available, however, alcohol, disinfecting it alked
- . Disinfection activity shall be done before and after the activity by the organizer; mointenance
- The organizer shall contribute for the payment water and electricity bills;
- There must be health personnel who will monitor the health and safety protocols;
- The organizer shall clean the school premises after the activity;
- The organizer shall provide beddings, drinking water, and foods for the participants; and
- The consent of the LGU of Digos City are sought in the use of public schools of Digos, considering the Alert Level Status of Digos City and on the number of participants/athletes and coaches that will be billeted in the said schools, in which the said schools of the said schools of the said schools of the said schools.

DIDI CAGAS SWIMMING COMPETITION FOR THE ARAW NG DAVAO DEL SUR

DATE: JUNE 24-26, 2022

#### FACTS:

• In reference to the Inter-Agency Task Force (IATF) for the Management of Emerging Infectious Diseases on the Guidelines of the Nationwide Implementation of Alert Level System for COVID-19 Response, for areas under Alert Level 3, activities shall be conducted at a maximum of 30% indoor venue capacity for fully vaccinated individuals only and 50% outdoor venue capacity provided that the organizers of the activity are fully vaccinated against COVID-19 while for areas under Alert Level 2, activities shall be conducted at a maximum of 50% indoor venue capacity for fully vaccinated individuals and those below 18 years old of age, even if unvaccinated, and 70% outdoor capacity provided that the organizers of the activity are fully vaccinated against COVID-19.

### RECOMMENDATIONS:

- Proper coordination with the PSDSs and School Head must be made.
- The vaccination status of the participants shall be checked.
- An inventory shall be made before and after.
- There must be a logbook available for contact tracing.
- During the activity, social/physical distancing shall be observed as well as the wearing
  of face masks, checking of body temperature, sanitizing or washing their hands and foot
  bathing at the entrance of the venue.
- Comfort rooms and hand washing facilities must be functional and allowed for use during the event.
- Disinfection activity shall be done before and after the activity by the organizer.
- The organizer shall contribute for the payment water and electricity bills.
- There must be health personnel from the Province who will monitor the health and safety protocols.
- The organizer shall clean the school premises after the activity.
- The organizer shall provide beddings, drinking water, and foods for the participants.
