**2022 OPLAN BALIK ESKWELA (OBE) DIVISION GUIDELINES**

To: Assistant Schools Division Superintendent  
Chiefs, CID and SGOD  
Education Program Supervisors  
Public Schools District Supervisors  
Public Elementary and Secondary School Heads

1. Pursuant to DepEd Order No. 34, series of 2022 and Regional Memorandum No. 55, series of 2022, the Schools Division of Digos City shall implement Oplan Balik Eskwela from August 1 – 26, 2022 in preparation for the opening of School Year 2022-2023.
2. The Division Office and Schools are hereby instructed to compose the Oplan Balik Eskwela – Public Assistance Command Center (OBE-PACC). The composition shall be as follows:

3. The OBE-PACC shall ensure the implementation of necessary health and safety protocols, health standards, social distancing measures, proper hygiene, DOH standards and other relevant national, regional and local protocols.
4. The Curriculum and Implementation Division shall work with the regional monitoring team which shall be conducting OBE monitoring on August 22, 2022.
5. The CID is also advised to prepare a monitoring mechanism to ensure that teachers and classrooms shall be ready for the limited in-person classes which shall commence on August 22 towards full implementation by November 2022.
6. PRME shall devise a dashboard for the monitoring reports.
7. For immediate dissemination and compliance.

1. Pursuant to DepEd Order No. 34, s. 2022, The Department of Education (DepEd) will conduct the Oplan Balik Eskwela (OBE) for School Year 2022 – 2023 from August 1 – 26, 2022. The OBE Command Conference shall be held on August 15, 2022.
