 - Must be a Permanent teacher within the district.
 - Participants shall be Single.
 - Substitute, LSB, PSB and/or LSA are not allowed to join the

- The Search shall have the following categories:
 - Creative Attire
 - Casual Attire
 - Modern Filipiniana (Ladies)
 - Barong Tagalog (Gentlemen)
 - Ouestion and Answer

Teachers Got Talent

- 1. The contest is open to public school teachers whether individual or group (8-10 members only).
- 2. Each district shall have one entry.
- 3. The contest is open to any type of act or performance such as singing, dancing, acting, etc. as long as the following items are strictly followed:
 - a. No acrobatics and no pyramid are allowed.
 - b. The use of combustible materials is not allowed.
 - c. No vulgar, rude and improper costumes and choreography in the whole performance
- 4. The allotted time for the performance is 3-5 minutes only, including the entrance and exit. Two (2) points will automatically be deducted for each minute in excess of the allowed duration.
- 5. The contestant/s shall bring their own props and musical accompaniments.
- 6. The criteria for judging are as follows:

Cheers and Yells

- 1. Every District should only have one (1) entry
- 2. Performance should be a minimum of 1 minute and a maximum of 2 minutes only. A deduction will be given to the team if they will exceed to the limit.
- 3. Concept is unlimited and freestyle. Various dance art is highly appreciated to promote originality, creativity and high level of novelty.
- 4. Yells should not include degrading words pertaining to other district.
- 5. Costume is unlimited and freestyle as long as your District color is dominant to promote originality, creativity, elegance and decent aura.
- 6. Acrobatic executions such as lifting, tossing, and dangerous stunts such as back tumbling are not allowed.
- 7. Any violations of the rules and regulations within the mechanics of the cheer and yells competition will be subjected to 1 point deduction from the total score.
- 8. Cheers and yells will be performed during the opening program on Oct. 7, 2022

- 1.) The On-the-Spot Painting contest is open to teachers in the Division of Digos City. Maximum of 5 teachers per District will be accepted.
- 2.) All interested participants must submit their intent to their PSDS.
- 3.) Participants are expected to have a realistic painting. The focus of the painting will be announced on the day of the contest.
- 4.) 18' x 24' drawing pads/cartolina for the contest will be used.
- 5.) Contestants must provide their own painting materials.
- 6.) No specific medium for painting is required.
- 7.) All artworks must be done on the spot and must be completed within the allotted time of two hours (2 hours).
- 8.) All entries will be pre-numbered. No other identifying marks will be allowed to appear in the artworks.
- 9.) Participants shall waive their rights to their paintings in favor of the Division Office for general publication, promotional use and other purposes deemed necessary with the proper and due acknowledgement and recognition of the painters.
- 10.) If the participant comes late, he/she may still be accommodated but will not be given time extension.
- 11.) The decision of the Board of Judges shall be final and irrevocable.
