

The Department of Education, being the largest bureaucracy in the government, regularly collects data through its information systems—the enhanced Basic Education Information System (eBEIS), the Learner Information System (LIS), the Basic Education Information System (BEIS), and the National School Building Inventory (NSBI)—to aid top management in its decision making that will provide quality, accessible, relevant, and liberating education to its stakeholders. These include, but not limited to learners, teachers, classrooms, schools, programs, projects, and other resources such as water, electricity, internet connectivity, etc.

The data being collected by DepEd is used for various reasons, e.g., allocating resources, budgeting, and decision making, making data an integral part of strategic planning. Hence, annual data gathering as a startup procedure is vital to decision making. Also, data is used in order to analyze and suggest improvements in its systems for its enhancement of data collection used for various purposes.

In this regard, the Planning Service - Education Management Information System Division (PS-EMISD) will conduct a **Data Management and Information Requirements for SY 2022-2023 Workshop** in three clusters. The purpose of the said workshop is to:

1. Provide updates on roles/responsibilities/accountabilities;
2. Discuss additional/revised data elements in the BEIS forms; and
3. Introduce new facilities in the system (LIS, BEIS, and eBEIS).
