Attached is the Memorandum from the Office of the Undersecretary for Governance and Field Operations dated **October 12, 2022**, entitled "**Conduct of the Child Protection Unit (CPU) 30<sup>th</sup> National Children's Month Regional Activities**".

Pursuant to Republic Act No. 10661 or the "National Children's Month Act," the Department of Education (DepEd) through the Child Protection Unit (CPU) partners with the Council for the Welfare of Children (CWC) for the celebration of the 30<sup>th</sup> National Children's Month (NCM).

For this year, the theme will be "**Kalusugan, Kaisipan, at Kapakanan ng Bawat Bata Ating Tutukan!**", which focuses on the mental health and well-being of the children as the crucial issues at present which need attention and response in the local and national levels of governance.

Specifically, the month-long celebration aims:

1. To acknowledge the magnitude of the mental health concerns among children pre and during the COVID-19 pandemic;
2. To meet and improve the mental health needs of Filipino children since the onset of the COVID-19 pandemic through activities that respond to the categories of children's rights to survival, development, protection, and participation; and
3. To converge efforts and services and share the good practices to find the knowledge gaps of the local government units, government agencies, and non-government organizations in addressing the children's mental health concerns.

In line with this, all Schools Division Offices (SDOs), and schools are requested to conduct the following suggested activities:

1. Vaccination Drive, Dental and Medical Mission;
2. Activities for Self-Care, Health, and Wellness Practices in Schools;
3. Poster Making Activities per school;
4. Information Drive on Child Rights Advocacy entitled: "**Ako ay Mag-aaral: Mga Karapatan sa Paaralan, Isulong at Panindigan**"; and
  - a. IEC Material/s to be provided by CPU – poster of child rights

- b. To be posted on transparency/bulletin board – SDOs, and schools
- 5. Anti-Bullying Campaign in Schools (Details on attached Annex A).**
- Anchored on the theme and core aspects of the CPU Anti-Bullying Advocacy Campaign;
  - IEC materials, pub mats, and social media cards for information dissemination in schools and for use in the official social media platforms of the field offices; and
  - Conduct orientations in schools on Bullying and Bullying Prevention.

Further, all SDO Child Protection Focal Persons are requested to act on the following action points:

**I. Kick-off NCM Celebration (1<sup>st</sup> Week of November)**

- Disseminate to lower counterparts the mechanics of the NCM-Logo Making Contest as uploaded on the CWC Facebook Page;
- Recite the Panatang Makabata using any of the 38 available Philippine native language translations or the Filipino Sign Language interpretation every Monday, during flag ceremonies and opening ceremonies of child-focused activities;
- Upload the official NCM banner/cover photo on the official websites and social media pages; and
- Adopt, disseminate, and localize NCM-related memoranda.

**II. During the NCM Celebration (Whole Month of November)**

- Tag or mention the CWC Facebook page in all NCM-related social media posts;
- Attend the CWC/RSCWC-led national and regional NCM activities as live-streamed on the CWC and RSCWC Facebook pages, or as invited in face-to-face activities; and
- Conduct NCM activities that will not coincide with the schedule of the National NCM Kick-Off Ceremony on November 3, 2022 (Thursday) at 9:00 am, if possible.

**III. Post-NCM Celebration (December)**

- All SDOs shall develop and submit a post-NCM activity write-up/article with a maximum of 300 words including photos with caption not later than December 12, 2022 (Monday) to [stephenmark.castres@deped.gov.ph](mailto:stephenmark.castres@deped.gov.ph).

SUBJECT: THE 30<sup>TH</sup> NATIONAL CHILDREN'S MONTH (NCM) CELEBRATION

By virtue of Republic Act No. 10661 also known as National Children's Month (NCM), this celebration is observed every November to commemorate the adoption of the United Nations Convention on the Rights of the Child (UN CRC) on 20 November 1989. It seeks to instill its significance in the Filipino consciousness, as well as sustain the promotion and protection of children's rights. Section 3 of the law states that the Council for the Welfare of Children (CWC), National Youth Commission (NYC), and the Department of Social Welfare and Development (DSWD) are the lead agencies of NCM every November.

According to the National Center for Mental Health (NCMH), suicide-related calls grew three times during the pandemic, and its Crisis Hotline received an increase in the daily calls from 32 to 27. Overall, 9.7% is suicide-related and 251 of the callers were minors.

Following the concerns experienced by the children since the onset of the COVID-19 pandemic, the Council for the Welfare of Children (CWC) with the Consuela Zobel Alger Foundation initiated the Kuwentuhan (Learning/ Consultation Sessions with Children) during the 29<sup>th</sup> National Children's Month (NCM) in November 2021. In this activity, child participants themselves shared the most pressing issues for them at present, and this resulted to their consensus recommendation for the 30<sup>th</sup> NCM to focus on *mental health and well-being of children*. This recommendation was also supported by the result of the NCM post-event evaluation, and the concurrence of the National Steering Committee on Child Rights Advocacy (NSC-CRA), Technical Management Group (TMG), and the CWC Board led to the adoption of the 30<sup>th</sup> NCM theme "*Kalusugan, Kaisipan, at Kapakanan ng Bawat Bata Ating Tutukan!*"

According to the World Health Organization (WHO), health, in general, is "*a state of complete physical, mental and social wellbeing and not merely the absence of disease or infirmity.*" Particularly, mental health is an integral and essential component of health while well-being frames health as a positive aspiration.

Mental health has been a growing concern among children before and during the COVID - 19 pandemic. It induced higher levels of stress within their families or household, limited their access to mental health services and programs, and challenged their access and means of participation. Hence, the NCM's focus and the theme will uncover how mental health cuts across children's right to survival, development, protection, and participation, and how we can collectively call for actionable changes crucial to children's overall well-being.

Special celebrations on children will also be simultaneously observed: the 3rd week of November as the National Play Advocacy Week led by the Philippine Play Coalition, and the Juvenile Justice and Welfare Consciousness Week led by the Juvenile Justice and Welfare Council in the 4th week of November.

Specifically, the month-long celebration aims to:

4. RECITE the Panatang Makabata using any of the 38 available Philippine native language translations or the Filipino Sign Language interpretation every Monday, during Flag Ceremonies and opening ceremonies of any child-focused activities;
5. UPLOAD the official NCM banner/cover photo on the website and social media pages and
6. ADOPT, DISSEMINATE, AND LOCALIZE NCM-related memoranda issued by relevant national agencies;

**II. DURING THE NCM CELEBRATION (NOVEMBER):**

1. TAG OR MENTION the CWC Facebook Page in all NCM-related social media posts;
2. ATTEND the CWC/RSCWC-Led national and regional NCM activities as live-streamed on the CWC and RSCWC Facebook Page, or as invited in face-to-face activities, and
3. CONDUCT AGENCY NCM activities that will not coincide with the schedule of the National NCM Kick-Off Ceremony on 03 November 2022 (Wednesday) at 09:00 AM, if possible.

**III. POST-NCM CELEBRATION (DECEMBER):**

1. DEVELOP AND SUBMIT a post-NCM activity write-up/article with a maximum of 300 words and photos with caption not later than 16 December 2022 (Friday) to [ncm@dfa.gov.ph](#) or at [ncm@rscwc.gov.ph](#) (Please see attached sample).
