3. Mrs. **Cherry Lyne V. Gonzaga** shall perform the functions, duties and responsibilities stipulated in the compendium as Program Specialist II, to wit:
  - a. assists the PSDS and ALS Supervisor in coordinating activities on ALS programs & projects
  - b. conduct instructional supervision
  - c. monitor & evaluate and provide technical assistance to ALS Learning Facilitators (Mobile Teachers, DALSCs, Literacy Volunteers, Instructional Managers, Facilitators) at the District level)
4. As such, all the teaching loads and enrolled learners of Mrs. Cherry Lyne Gonzaga will be prorated to other ALS Teachers.
5. This shall take effect immediately upon issuance unless appropriately revised or revoked by a competent authority thru the issue of an order/memorandum.
