Per DepEd Order No. 53, s. 2003 or the Updated Guidelines on Grant of Vacation Service Credits to Teachers indicates that attendance/participation in special DepEd Projects and activities which are short term in duration is considered as one of the identified activities eligible for the grant of Service Credits for teachers and Compensatory Overtime Credits (COC) for non-teaching personnel who have served during Saturdays, Sundays, and including Holidays.

Thus, this Office advises the Schools Division Offices (SDOs) to grant service credits to the teachers and COC to the non-teaching personnel, who have rendered services on January 14, 15, 21, 22, 28 and 29, 2023 which falls on Saturdays and Sundays, covered in the above mentioned activity.
