This certification, to be submitted, in lieu of the CV forms, is necessary so that the 4Ps household beneficiaries will receive their educational cash grants for Compliance Period 5.

This is consistent with previous pronouncements and policy directives to unload teachers of tasks not related to teaching.

With reference to OUGFO Memorandum No. 2022-03-3666 titled Updated Instruction on School Reporting for the Pantawid Pamilyang Pilipino Program (4Ps) (Annex A), this Office informs all concerned that per DepEd's coordination with the DSWD, the deadline for the submission of the required certification explained in the OUGFO memorandum has been moved from December 23, 2022 to January 16, 2023.
