PRC XI is deeply grateful for the unceasing support your office has been extending us through the years as we continually deliver our mandate in serving the public, particularly our dear professionals.

Once again, this office would like to invite your agency as one of our partners in the conduct of the Licensure Examinations for Professional Teachers on 19 March 2023 (Sunday) in our four (4) Testing Sites in the cities of Davao, Digos, Mati and Tagum. As of this writing, PRC XI is expected to administer the said examinations to 10,930 examinees (7,096 in Davao City, 1,377 in Digos City, 409 in Mati City and 2,048 in Tagum) hence, PRC XI shall be in need of the following:

- 1. Public Schools in Davao, Digos and Tagum Cities that have non-air-conditioned Classooms (with fans for ventilation and a 1.5 meter radial distance between chairs) that can accommodate at least eighteen (18) examinees
- 2. Tables and Chairs for Examinees and Examination Personnel
- Z. Licensed Professional Teachers in <u>Digos</u> and <u>Tagum Cities</u> who could serve as Room Watchers, and other Examination Personnel who will serve in the Digos and Tagum Testing Sites

This office is looking forward to your most positive response regarding this matter preferably on or before **06 February 2023**.

On the other hand, if this invitation merits a favorable response, PRC XI would also like to conduct ocular inspections of your schools in Digos, Tagum and Davao Cities between 08 to 15 February 2023.
