Date : March 28, 2023

Attached herewith is the letter from the City Health Officer, Milagros R. Sunga, MD dated March 7, 2023, requesting to conduct a School-Based Vaccination on Covid-19 to all public schools of DepEd- Digos City Division. The vaccination will be conducted every Friday from 1:00 to 3:30 PM on different school venues to be announced on the group chats of the **Health and Schools Administrators, Covid-19 Vaccination Advocates** and **HIMSOG Advocates**.

This Covid-19 Vaccination drive is in relation to the low vaccination coverage of our 5-11 years old age group, and the continuous and consistent efforts to reach herd immunity for each target population of the Department of Health with the strong support from the Department of Education.

In connection to this, we would like to request the schools to prepare a venue for the vaccination preferably at the gymnasiums, and also to prepare chairs and tables for the team to utilize. The schools should strictly follow the entrance and exit points for all vaccinees. A crowd control will be strictly observed during vaccination. Policy on "No Disruption of Classes" as per DepEd Order No. 09, s. 2005 shall be strictly followed.

Schools should gather the number of the learners who wishes to be vaccinated prior to the schedule and should submit it to the Covid-19 Vaccination Division Focal prior to the schedule. Learners who wish to be vaccinated should only be accompanied with one parent. Only learners of the certain school will be vaccinated.

All School Clinic In-charge will conduct a widespread information dissemination on the said vaccination, specifically its schedule and requirements to bring during vaccination.

District nurses and the secondary nurse will monitor the said vaccination for their respective school assignments.

Dear Doctor Sunga,

This is in response to your letter dated March 7, 2023 on the School-Based Covid-19 Vaccination that will be held during Fridays from 1:00 to 3:30 PM to all public schools of DepEd- Digos City Division.

Based on the latest IATF guidelines, Digos City is still under Level 2, which states that all national government agencies and instrumentalities, as well as private sector establishments, shall adopt measures to strictly implement and enforce the minimum public standards set by DOH and other standards set by relevant government agencies.

The Schools Division of Digos City strongly supports the said drive provided that during the said schedule for vaccination on the schools, the following shall be strictly observed:

1. The learners will be accompanied with only one parent,
2. Only the students of that certain school will be vaccinated,
3. Accompanying parent will only be allowed to enter the school premises during the time of the vaccination,
4. Entrance and exit points will be strictly followed,
5. A crowd control will be strictly observed during vaccination.
6. Policy on "No Disruption of Classes" as per DepEd Order No. 09, s. 2005 will be strictly followed.


