Pursuant to the mandate of the Curriculum and Learning Management Division to supervise the Schools Division Offices in the full implementation of the Basic Education Curriculum (BEC) and Special Curricular Programs, this Office informs the conduct of the Regional Consultative Conference of Education Program Supervisors in SPFL, on May 6, 2023, from 8:00 AM to 5:00 PM, via an online platform. The online link will be provided in a later advisory.

The activity aims to:

1. revisit the duties and responsibilities of Education Program Supervisors in the management of SPFL curriculum implementation;
2. discuss the following:
 - a. mechanics and guidelines of the 2023 National Festival of Talents;
 - b. timeline for the conduct of the Festival of Talents at the school, division, and regional levels;
 - c. requirements for the expansion of SPFL in the non-implementing SDOs; and
3. align the SDO activities with the planned activities at the regional level.

The activity shall be participated by the Regional and designated SPFL Supervisors in the 11 SDOs. All participants are advised to secure the best internet connectivity during the entire duration of the conference to ensure full and active participation.

All expenses incurred in the participation of all SDO EPS in SPFL shall be charged against local funds/MOOE, subject to the rules and regulations of the usual accounting and auditing procedures.

Per DepEd Order 53 s., 2003 or the updated Guidelines on Grant of Vacation Service Credits to Teachers, service credits be granted to teachers and Compensatory Time-Off for non-teaching personnel, for "attendance/ participation in special DepEd projects and activities which are short-term in duration such as training, curriculum writing workshop, planning workshop, etc., if such are held during vacation or during weekends."
