Pursuant to the objective to contribute to the improvement of region-wide performance specifically on learning outcomes by helping the full implementation of the articulated basic education, this Office informs the conduct of the **Second Quarter Regional Consultative Conference of Education Program Supervisors in EsP, on May 7, 2023, from 8:00 PM to 5:00 PM, via an online platform.** The online link will be provided in a later advisory.

The activity aims to:

1. consolidate, evaluate, and assess the result of the unified Quarter 3 Summative Test in EsP;
2. plan for an activity to contextualize the curriculum to improve learning outcome
3. formulate policies that would improve the implementation of the articulated curriculum in EsP; and
4. discuss concerns, issues, gaps, and problems in the implementation of the Homeroom Guidance Program.

The participants in this activity are the Regional and Division EsP EPS in all 11 SDOs. All participants are advised to secure the best internet connectivity during the entire duration of the conference to ensure full and active participation.

All expenses incurred in the participation of all SDO EPS in EsP shall be charged against local funds/MOOE, subject to the rules and regulations of the usual accounting and auditing procedures.

Per DepEd Order 53 s., 2003 or the updated Guidelines on Grant of Vacation Service Credits to Teachers, service credits be granted to teachers and Compensatory Time-off (CTO) for non-teaching personnel, for "attendance/ participation in special DepEd projects and activities which are short-term in duration such as training, curriculum writing workshop, planning workshop, etc., if such are held during vacation or during weekends."
