## **Activity Request (AR)**

a plan implementation document secured prior to the conduct of an activity which is included in the approved WFP (Original and Adjusted) and within the set threshold.

## **Annual Procurement Plan (APP)**

It is the consolidated Project Procurement Management Plan (PPMP). This document reflects the necessary information on the entire procurement activities that is planned to be undertaken within the calendar year.

## Annual Procurement Plan - Commonuse Supplies and Equipment (APP-CSE)

an Annual Procurement Plan which outlines the common- use supplies and equipment of the operating unit to be procured by the supply unit for the entire fiscal year.
