The Department of Education (DepEd) developed the Quality Control Checklist (QCC) as per D.M 28, s. 2022 for completed basic and action research to reinforce quality control in research management as per DepEd Order 16 s. 2017 known as the Research Management Guidelines (RMG) and quality control of Research Portal content as per DepEd Order 14 s. 2022. Particularly, it provides specific criteria and serves as a tool in evaluating the quality of completed research for acceptance and archiving in the Research Portal. It can also be used to identify the areas for technical assistance to researchers.

The QCC shall be used in evaluating the quality of completed studies for:

- Acceptance of BERF-funded research by research committee starting FY 2022. The QCC shall determine whether the completed research meets the minimum standards required for acceptance per DepEd Order 16, s. 2017; and
- Archiving in the Research Portal as stipulated in DepEd Order 14, s. 2022.

As one of the indicators in the Agency Performance Monitoring Report for Submission to DBM for FY 2023, 11 Schools Division Offices are hereby directed to fast track the submission of validated QCC with the final research output through <https://bit.ly/RQCCsub> for uploading to the E-saliksik Portal.
