1. This is to reiterate Presidential Proclamation No. 1782, s. 2009 titled "Declaring the Month of June as W.A.T.C.H. (*We Advocate Time Consciousness and Honesty*) Month and enjoining all Schools, Colleges, Universities, and Local Government Units to undertake programs of activities relating thereto every second week of June".

2. In observation of the 2023 W.A.T.C.H. Month Celebration, all Project W.A.T.C.H. School Coordinators of this division are enjoined to conduct any of the following suggested activities:

- c. Wear anything yellow on all Fridays of June (#YellowFridays) to signify support for the celebration of W.A.T.C.H. month.
- d. Conduct oratorical and time games in student activities.
- e. Distribution of time management tools and materials.
- f. Other activities that promote and undertake programs that will instill the value of punctuality and honesty in all sectors of society.


3. The activities to be conducted which are not included in the suggestions above should at least focus on one of the four core areas of Project W.A.T.C.H. Program: (a) Advocacy Campaign, (b) Training/Orientation, (c) Curriculum Integration and (d) W.A.T.C.H. Club Activities.
