Subject: REITERATION ON THE IMPLEMENTATION OF THE NATIONAL

LEARNING CAMP (NLC)

Date : July 20, 2023

In reference to RM-CLMD-2023-377, dated July 7, 2023 entitled "Implementation of the Regional Learning Camp", this office informs the conduct of Learning Camp in the Schools Division from **July 24 to August 25, 2023.**

Based on the specific needs of the learners, they shall be enrolled in one of the three Camps: Enhancement Camp, Consolidation Camp, or Intervention Camp. The **Enhancement Camp** enriches learning for advanced learners by providing greater depth, breadth, and complexity of learning area competencies while **Consolidation Camp** provides further practice on and application of previously taught competencies. **Intervention Camp**, on the other hand, supports learners who are yet to grasp Foundational Mathematics and/or Foundational English skills. It also included **Remedial Classes** for learners who did not meet the expectations in terms of attaining the learning competencies required of a particular learning area.

The Enhancement Camp shall be conducted from July 24 to August 11, 2023, while the Consolidation Camp and Intervention Camp shall be conducted from July 24 to August 25, 2023.

The **three (3) days** of the week shall be dedicated to structured and targeted teaching learning activities with the learners, while the remaining **two (2) days** shall be allocated for collaborative sessions among the teachers.

Key Stage 1, (Kinder to Grade 3) will focus on Literacy and Numeracy. Each subject (Literacy and Numerary) shall be given one (1) hour and thirty (30) minutes each day for three (3) days in a week. On the other hand, Key Stage 2 to 4, (Grades 4-6 and Grade 9-12), shall cover subjects in English, Math and Science, each will be given a one (1) hour time allotment in a day for three (3) days.

The participation of Teachers in the conduct of the Learning Camp is voluntary in nature. Hence, no teacher will be compelled to participate in the activity. On the other hand, students are encouraged to join the Learning camp but strictly on a voluntary basis. Moreover, a Waiver must be sought from the teacher will to signify hir/her voluntary participation, while students shall present his/her signed Parental Consent to signify his/her voluntary participation.

All teachers involved in the Learning Camp shall be granted Vacation Service Credits for the services rendered during the activity. The number of service credits authorized is exclusive of the fifteen (15) days maximum vacation service credits allowed as stipulated in DO 53, s. 2003, Updated Guidelines on the Grant of Vacation Service Credits to Teachers.

To defray the expenses which shall be incurred in the conduct of the Learning Camp, funds shall be downloaded to each school to cover expenses which include meal expenses of teachers, printing of advocacy materials, reproduction of teaching and learning materials and resources, assessment tools and reading worksheets, and delivery of materials.
