2023-2024 FOR PRIVATE SCHOOLS**

Pursuant to the enclosed OASOPS No. 2023-149 dated August 3, 2023, with the same title above, this Office informs the field that as stipulated in Republic Act (RA) No. 11480 or an Act Amending Section 3 of RA No. 7797, otherwise known as an Act to Lengthen the School Calendar from two hundred (200) Days to Not More Than Two Hundred Twenty (220) Class Days, **private schools may begin their operations earlier than the public schools, provided that the earliest opening of classes is on the 1<sup>st</sup> day of June but not later than the last day of August.**

Relative to this, private schools shall submit two sets (hard copy) of their approved school calendar of activities to the Division Office addressed to the SDS, attention: Ida I. Juezan, for compilation then submission to the Regional Office. Likewise, the private schools are also encouraged to fill up the google sheet posted at the Private Schools Group Chat (GC) for monitoring purposes.



SUBJECT : **ADVISORY ON THE OPENING OF CLASSES FOR SCHOOL YEAR 2023-2024 FOR PRIVATE SCHOOLS**

In view of the opening of classes for School Year 2023-2024, **private schools may begin operations earlier than public schools, provided that classes open on the 1<sup>st</sup> day of June but not later than the last day of August**, as stipulated in Republic Act (RA) No. 11480 or an act amending Section 3 of RA No. 7797, otherwise known as *An Act to Lengthen the School Calendar from Two Hundred (200) Days to Not More Than Two Hundred Twenty (220) Class Days*.

Likewise, private schools must submit their school calendar to their respective regional offices to validate the requirements.
