In relation to the issued Regional Memorandum no. 17, s. 2023, entitled "Guidelines on the 2023 Regional Research Congress", this Office provides the following additional information and adjustment of indicative timeline.

1. The 2023 Regional Research Congress is moved to September 2-3, 2023 at Apo View Hotel, Davao City.
2. The deadline of the submission of all entries (manuscripts and presentation materials) is move from August 18, 2023 to August 25, 2023 except for best paper category.
3. All manuscript cover page shall follow the e-saliksik format.
4. Policy brief category entries shall prepare 10 printed copies of the briefer in A4 size.
5. Only the 2022 BERF grantees is allowed to join the best paper category.
6. Travelling and other incidental expenses of the participants shall be charged to local funds subject to the usual accounting and auditing rules and procedures.
7. Service rendered during the activity shall be subject to grant of service credits and or Compensatory Overtime Credit (COC) as the case maybe per DO No. 53, s. 2003 and CSC & DBM Joint Circular No. 2, s. 2004 respectively.
