

A RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID AND RECOMMENDING TO THE SCHOOLS DIVISION SUPERINTENDENT THE APPROVAL TO AWARD THE CONTRACT FOR PROJECT NO. 23-06-069: PROCUREMENT OF FOOD SUPPLIES FOR THE IMPLEMENTATION OF SCHOOL-BASED FEEDING PROGRAM TO CY 2023-2024 LOT 3 – PROCUREMENT OF FORTIFIED RICE TO D'PARAGON AA CORP

WHEREAS, Republic Act No. 9184 provides for the modernization, standardization and regulation of the procurement activities of the Government;

WHEREAS, for “*Project No. 23-06-069: Procurement of Food Supplies for the Implementation of School-Based Feeding Program for CY 2023-2024 Lot 3 – Procurement of Fortified Rice*”, DepEd - Digos City Division, with the ABC of *One Million Two Hundred One Thousand Fifty Pesos (Php 1,201,050.00)* through the Bids and Awards Committee (BAC), proceeded with Procurement observing the procurement procedures as provided for in R.A. 9184;

WHEREAS, on July 25, 2023, the Opening of Bids for Project No.23-06-069 Lot 3, which was participated by Sta. Catalina Multipurpos Cooperative and D'Paragon AA Corp., was done;

WHEREAS, the first envelop opened was from Sta. Catalina Multipurpose Cooperative was declared non-complying due to deficiency of stamped “received” on the Supplier’s Audited Financial Statements as part of the Eligibility and Technical Requirements on the Financial Documents;

WHEREAS, the last envelop opened was from D'Paragon AA Corp. and was declared complying with the Eligibility and Technical Requirements based on the documents submitted and quoted the amount the same amount of One Million Ninety-Nine Thousand Six Hundred Twenty-Eight Pesos Pesos (Php 1,099,628.00);

WHEREAS, on July 27, 2023, the Technical Working Group (TWG) conducted the Detailed Bid Evaluation of the submitted bid documents where D'Paragon AA Corp. was considered as the lowest calculated bidder as read the offering amount of One Million Ninety-Nine Thousand Six Hundred Twenty-Eight Pesos Pesos (Php 1,099,628.00);

WHEREAS, on August 1, 2023, the Technical Working Group (TWG) conducted Post Qualification of the lowest calculated bidder, and after their thorough evaluation on the documents, production site, and the sample Fortified Rice submitted, D'Paragon AA Corp. was declared responsive;

WHEREAS, during the BAC meeting held on August 4, 2023, taking into consideration the report of the Technical Working Group, and on motion of BAC Member Mr. Clarence S. Pillerin, which was seconded by BAC Vice Chairperson Mrs. Cherry Rossette E. Oliva, **D'PARAGON AA CORP.** was declared as the Lowest Calculated Responsive Bidder as read for “*Project No. 23-06-069: Procurement of Food Supplies for the Implementation of School-Based Feeding Program for CY 2023-2024 Lot 3 – Procurement of Fortified Rice*”;
