In reference to Girl Scout of the Philippines (GSP) Council Office Council Circular No.36 s. 2023 dated October 3, 2023, the field is informed of the conduct of the SAVER (SERVICE AUXILLIARY VOLUNTERS FOR EMERGENCY AND RELIEF) training on October 14-15, 2023, at the Ramon Magsaysay Covered Court, Digos City. This training aims to prepare the girls for any form of disaster and enable them to be useful in the community in time of emergency.

An Event Fee of One Hundred Pesos (Php100.00) per girl and Two Hundred Fifty Pesos (Php250.00) per adult shall be collected from each participant to cover the expenses to be incurred during the training, which includes badges, certificates, meals and training materials of the facilitators, and other incidental expenses.

Participant must be currently registered as a senior and cadet scout and willing to undertake the basic life support and personal safety and must be physically fit.

Corresponding service credits shall be granted to all accompanying Adult Leaders and compensatory overtime credits (COC) to the non-teaching staff /participants as provided for in DepEd Order No. 76, s. 2012.




