Following the issuance of Executive Order (EO) No. 174 titled "Establishing the Expanded Career Progression System for Public School Teachers," efforts are underway to operationalize the Expanded Career Progression (ECP) System in the Department of Education (DepEd). This encompasses the finalization of its comprehensive Implementing Rules and Regulations (IRR) and other auxiliary policies and guidelines to include, the DepEd Order outlining Guidelines on the ECP System and Reclassification of Teaching Positions. The Department of Education (DepEd) and relevant agencies are dedicated to expediting the full implementation of the ECP System while securing and incorporating inputs from incumbents and other stakeholders.
