Greetings in the name of sports!

The International Table Tennis Federation (ITTF) is conducting regular Umpiring Course all over the world for those interested personnel who wish to participate in officiating a table tennis tournament. This three-day course will give each participant the license to officiate in any competition upon passing the qualifying examination after the course. We have three levels of this course such as Basic Umpire Course (BUC) which gives the license holder to officiate in the Regional Table Tennis Competition, the National Umpire Course to officiate in the national level and the International Umpire Course, qualifying the license holder to officiate in the international level competition.

In this regard, we are considering facilitating the course in the Philippines with the collaboration of the Philippine Table Tennis Federation particularly in Davao City as highly requested by your sports enthusiasts who are license holder for national and the other one was an international license holder. The Basic Umpire Course (BUC) is scheduled in two batches on December 1-3 and December 8-10, 2023 at NEAP-XI, Quirino Street, Davao City. Most of the participants are DepEd teachers coming from different divisions in your region. Thus, at your discretion as a gesture of support to our active DepEd personnel may you grant them official time in the 1st and 8th day of December that is two Fridays so that they may not be marked absent during that activity. 5. Miscellaneous expenses during the training
