Mr. Granada is expected to be at the venue on February 5, 2024. The first meal to be served is dinner, while the last meal is PM snacks on February 9, 2024.




Expenses such as food and accommodation of all participants, and travel expenses of the NSAC members from the DepEd Central Office and personnel from the *Palarong Pambansa Secretariat* shall be charged against the Physical Fitness and School Sports (PFSS) Funds, while travel expenses of NSAC members from the field and RSAC/DSAC chairpersons and/or representatives shall be charged against their respective MOOE/local funds, subject to the usual government accounting and auditing rules and regulations.
