Provide your own drawing paper. The minimum size is A3 paper 42cm x29.7, and the maximum size should not be 54cm x 38cm. Chinese Painting size should not be larger than 4 sq. inches.

The types of entries are limited to painting works, with no restrictions on painting styles. They should be rich in imagination, observation, creativity and expression around the theme of the competition.

Third Prize	30	Welcome to attend the awarding ceremony at own travel expenses, will receive the certificate.
Outstanding Award	Several	Each organization could send one representative to attend the awarding ceremony (reimbursement of travel expenses).
Outstanding Group Award	Organizations that had submitted more than 200 entries, with some receiving third place or higher awards.

VII. Special Announcement

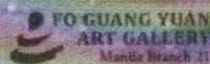
1. The organizing committee will send letters of notification to parents (guardian) of all winners for Special Award, First prize and Second prize. No reply after 7 days upon receipt of notification will be considered as giving up of prize award.
2. For Special Award, First Prize, Second Prize winners who cannot attend the awarding ceremony due to personal reasons, will be considered as giving up the prize award, he/she will only receive the certificate and collection of award-winning works.
3. Regardless of whether the submitted entries win or not, they will not be returned, and the copyright of the entries belongs to the organizers. The authors have the right to retain their names. The organizer reserves the right to preserve the works and use them in related activities, including but not limited to exhibitions, social media, and any promotional materials such as websites, posters, publications and etc. Furthermore, the organizers reserve the right to use the works for fundraising in charitable activities, including charity auctions, with no additional compensation provided for the aforementioned activities.

2. Re-evaluation: Selected entries will be notified by letter to send the original works through the school. Upon receiving the re-evaluation notice, the original works (please do not frame) should be sent to the co-organizer within 7 days via LBC express (postmarked as proof), with an A4 application form affixed on the back. Failure to send on time or loss of entries will result in disqualification from the re-evaluation.

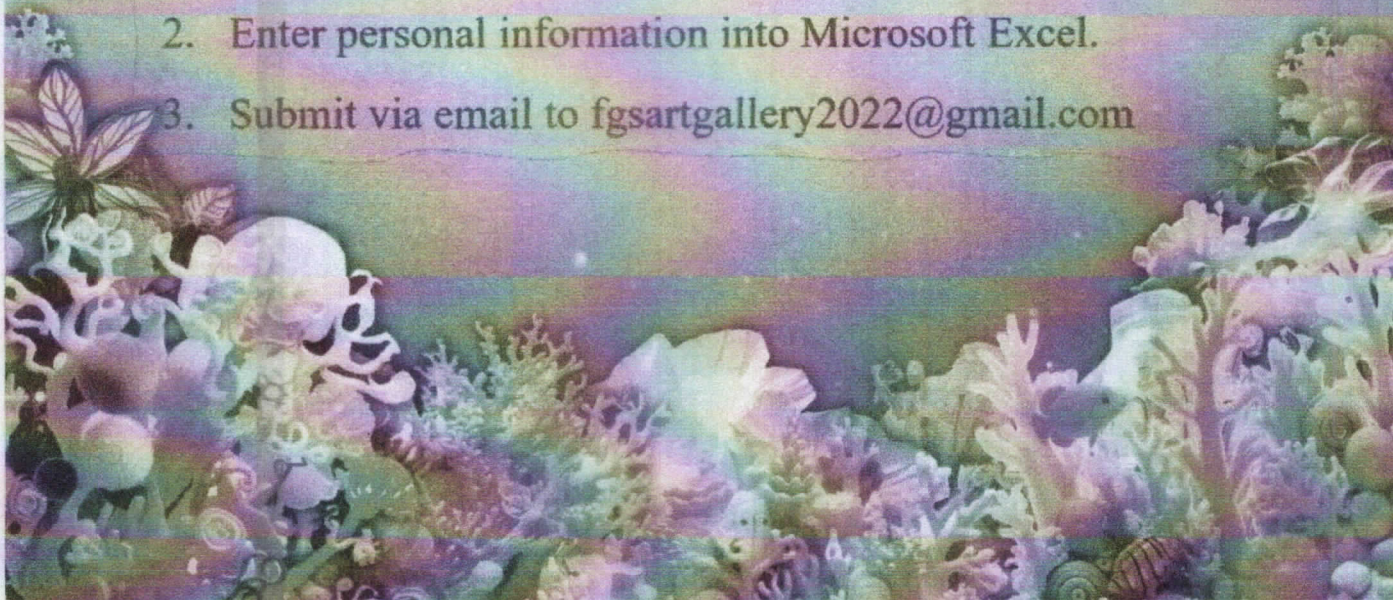
