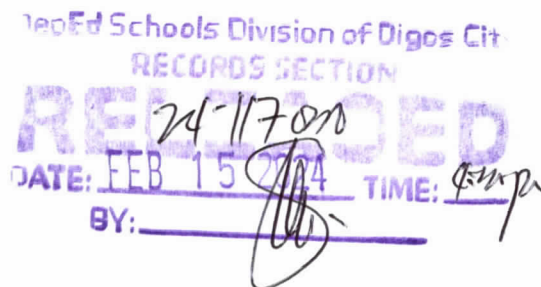
All application documents of schools, public and private, for government authority/permit to operate, however, shall be submitted first to the Schools Division Office (SDO) for evaluation.
