The following are the duties and functions of RSAC as stipulated in Section 3 of DepEd Memorandum No. 005, s. 2023:

“Duties and Functions of the RSAC and DSAC - The Regional Screening and Accreditation Committee and Division Screening and Accreditation Committee shall:

- a. evaluate and verify the authenticity of the documents of athletes, coaches, assistant coaches, and chaperones, submitted by the Head of Delegation for the Regional Meet in the case of RSAC and Division Meet in the case of DSAC;
- b. accredit qualified athletes, coaches, assistant coaches, and chaperones and submit the master list to the Regional Athletic Association or Division or Provincial Athletic Association, as the case may be; and
- c. monitor with the proper technical officials the athlete fielded by the coaches during the actual competition.”
