Pursuant to DO 86, s. 2009, DO 6, s. 2023 and DM 24, s. 2024, the Office of the Assistant Regional Director (OARD) shall now handle matters pertaining to Government Assistance to Students and Teachers in Private Education (GASTPE) such as but not limited to Education Service Contracting (ESC), Education Voucher System (EVS) and the Joint Delivery Voucher Program (JDVP). The OARD is expected to coordinate with the central and schools division offices including partner institutions, government and non-government organizations and oversight committees like Private Education Assistance Committee (PEAC) for the effective and efficient implementation of the programs cited.

Meanwhile, the Chief Education Supervisor of Curriculum and Learning Management Division (CLMD) shall provide the necessary transition of functions including available data and documents the soonest possible time to the OARD. A report shall be submitted to the Office of the Regional Director on the compliance.

This designation does not carry additional remuneration and shall take effect immediately until rescinded or repealed. Previous issuances inconsistent with this Memorandum is considered revoked.
