Pursuant to the Republic Act No. 9165 also known as “*Comprehensive Dangerous Drugs Act of 2002*” and DepEd’s initiative in addressing challenges related to drugs, this Office informs the field that the Division Federated Barkada Kontra Droga (BKD) Officers and Teacher-Advisers shall conduct a **R.A. 9165 Orientation, Parenting Sessions, Feeding Program, and Distribution of Learning Kits** at **Palan Bagobo Tagabawa National High School, Brgy. Binaton, Digos City** on **May 11, 2024 (Saturday) 8:00 AM – 12:00 NN**.

This activity aims to help the selected students and parents in Barangay Binaton to understand what role the school expects them to play by implementing activities like parenting sessions, parents-students focused group discussions, parents-students engagement, parents-students’ journeys, and other support-activities to promote intrinsic and extrinsic motivation and engagement of students in school.

Compensatory Overtime Credit (COC) of one (1) day shall be granted beyond regular hours and/or those rendered on Saturdays, Sundays, and Holidays, or scheduled days off without the benefit of overtime pay (CSC & DBM Joint Circular No. 2, s. 2004) “*Non-Monetary Remuneration for Overtime Services Rendered*” and DepEd Order No. 53, s. 2003 “*Updated Guidelines on Grant on Vacation Service Credits to Teachers*”, attendance/participation in DepEd activities which are short-time duration if such are held during summer vacation or during weekends. All learner participants shall secure parents’ consent.

Travelling expenses relative to the conduct of the activity shall be charged against local funds, subject to the usual accounting and auditing rules and regulations.

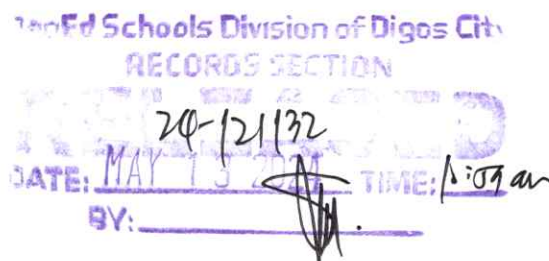
