(EEC) OFFICER AND FOCAL PERSONS

The Inter-Agency Energy Efficiency and Conservation Committee (IAEECC) issued Resolution No. 01, s. 2020 directing all government entities to comply with the Government Energy Management Program (GEMP) to reduce the government's monthly consumption of electricity and petroleum products through electricity efficiency and conservation in fuel use of government vehicles, among others. The Resolution and other IAEECC issuances provide the guidelines for the implementation of the GEMP, which includes the use of the savings realized through the implementation of the Energy Efficiency and Conservation Program (EECP) of the different agencies.

The EECP shall include energy efficiency and conservation measures, target savings, motor vehicle inventory, and other strategies that shall be implemented by the agency. The agency shall designate an EEC Officer and EEC Focal Persons to accomplish the tasks stated in the resolution.


