1. The time allotment for the Good Manners and Right Conduct/Values Education (GMRC/VE) and Homeroom Guidance classes shall not be affected.
2. The participation of DepEd learners must be with the consent from the parents.
3. No government funds shall be spent for the participation.
4. No government facility shall be utilized for the activity.
5. The policy on "No Disruption of Classes" per DepEd Order No. 9 s. 2005 entitled: "Instituting Measures to Increase Engaged Time-on-Task and Ensuring Compliance Therewith" shall be strictly observed.

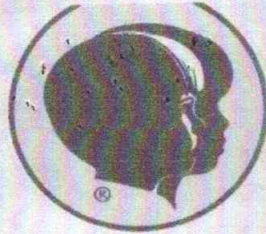


We believe our children play a great role in shaping our country in the future, thus their spiritual and moral formation is utmost importance to us.


