The School-Based Feeding Program (SBFP) is an excellent mechanism for select intervention in the school-age learners as it offers an opportunity not only for enhancing nutrition but also improving educational outcomes. The benefits of feeding school-age learners include alleviating hunger, reducing micronutrient deficiency and anemia, improving physical resilience, improving school enrolment and attendance; and increasing cognitive and academic performance.

DepEd SBFP shall cover only public primary beneficiaries' Severely Wasted (SW) and Wasted (W) Kindergarten to Grade 6 learners and shall be implemented for 175 days in which 160 days for regular class and feeding activity and 15 days for National Learning Camp 2025.

In every start of implementation, there are preparatory activities that shall be conducted in schools, to wit:


# Nutritional Status (NS) Assessment and Identification of beneficiaries.

All schools are expected to conduct Nutritional Status Assessment of Kinder to Grade 6 starting from Brigada Eskwela and identify the beneficiaries based on the data provided above.

If the number provided was greater than the identified beneficiaries, the school may opt to add learners who belonged to the secondary beneficiaries (Severely Stunted, Stunted, IP, PARDOs).

If the number provided was a little lesser, the remaining beneficiaries shall be fed thru partners and stakeholders.

The NS soft copy template to be used was already posted/ provided to SBFP group chat. This template was presented last SY 2023-24, therefore, it is expected that all schools will utilize the latest template the RO XI ESSD provided and for easy encoding and generating of data.
