1. Pursuant to Memorandum DM-CT-2024-401, from the Office of Gina O. Gonong, Undersecretary for Curriculum and Teaching, this Office informs the conduct of the 2024 Special Program in Foreign Language (SPFL) National Conference, with the Theme: "Navigating the Evolving Foreign Language Education Landscape: Perspective, Praxis, and Prospects," on October 23-25, 2024, within the National Capital Region.
2. The activity aims to share updates and best practices on the implementation of the Special Program in Foreign Language.
3. The activity participants are the Regional Education Program Supervisor (EPS) in charge of SPFL, select SDO EPS, school heads, and teacher implementers. The identified SPFL teachers are advised to prepare a presentation on their recent capacity-building engagement abroad and updates on how they apply it to support the ongoing implementation in their respective SDO or school.
4. The School Heads are advised to designate an Officer-In-Charge with authority confined only to administrative functions to ensure continuity of services, and to strictly observe the "No Disruption of Class Policy" as per DepEd Order No. 9, s. 2005 entitled "Instituting Measures to Increase Engaged Time-on-Task and Ensuring Compliance Therewith", by making sure that classes are properly managed during the participation of the identified SPFL teachers in the activity.
5. Expenses relative to the activity such as transportation, allowance, and other incidental expenses shall be charged against **OSEC-11-24-5257**, while meals and accommodation shall be charged against 2024 BCD-BEC Funds, subject to the usual accounting and auditing rules.


