## Resolution No. 02 Series of 2024

A RESOLUTION CALLING FOR A SPECIAL ELECTION IN THE DEPARTMENT OF EDUCATION NATIONAL EMPLOYEES' UNION (DEPED-NEU) DIGOS CITY CHAPTER TO FILL VACANCIES IN THE OFFICES OF PRESIDENT AND VICE-PRESIDENT DUE TO THEIR RESIGNATIONS.

WHEREAS, the Department of Education National Employees' Union (DepEd-NEU) Digos City Chapter is committed to ensuring effective leadership and representation for its members, in line with its objectives and responsibilities;

WHEREAS, the President, Mrs. Noreliza A. Misal, and the Vice-President, Mr. Reyzen O. Monsarate, have both resigned from their respective positions effective October 17, 2024, thereby creating vacancies in the leadership of the Union;

WHEREAS, the resignation of the President and Vice-President has left the Union without the necessary leadership required to carry out its responsibilities and to continue to represent the best interests of its members;

NOW, THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the officers of the DepEd-NEU Digos City Chapter in their official meeting held on October 17, 2024, that:

- 1. **A Special Election shall be held** to fill the vacancies for the President and Vice-President positions of the DepEd-NEU Digos City Chapter. This election will ensure that the Union has effective leadership moving forward.
- 2. The Special Election shall be conducted on October 18, 2024 at 11:30 AM at Crisbel Crown Center, Digos City, and all members of the Union are encouraged to participate in selecting new leaders who will serve the interests of the Union and its members.
- 3. Members currently in Emilia Healing Resort, Island Garden City of Samal, who are on official business, shall be allowed to participate in the Special Election via a virtual platform to ensure their active involvement in the election process. This provision

ensures that all members, regardless of their location, can actively engage in the election process.

- 4. The Union shall form a Special Election Committee composed of impartial members to oversee the election process, ensure transparency, and guarantee that the election is conducted fairly and in accordance with the Union's Constitution and By-Laws.
- 5. A notice regarding the Special Election shall be issued and disseminated to all members, detailing the election date, voting procedures, and nomination process.

**RESOLVED, FURTHER**, that this resolution be communicated to all members, and be made part of the official records of the Department of Education National Employees' Union Digos City Chapter.

Let this resolution take effect immediately.
