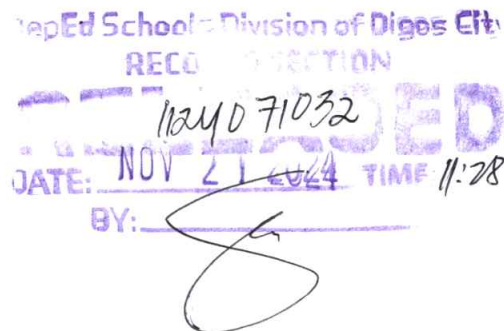
Compensatory Overtime Credit (COC) of one (1) day shall be granted beyond regular hours and/or those rendered on Saturdays, Sundays, and Holidays, or scheduled days off without the benefit of overtime pay (CSC & DBM Joint Circular No. 2, s. 2004) "Non-Monetary Remuneration for Overtime Services Rendered" and DepEd Order No. 53, s. 2003 "Updated Guidelines on Grant on Vacation Service Credits to Teachers", attendance/participation in DepEd activities which are short-time duration if such are held during summer vacation or during weekends. All learner participants shall secure parents' consent.

Travelling expenses relative to the conduct of the activity shall be charged against local funds, subject to the usual accounting and auditing rules and regulations.
